



# INTENSE LIGHTING WARRANTY

## 5-YEAR LIMITED WARRANTY FOR OUTDOOR LED PRODUCTS

Intense Lighting warrants to its customer and the original end user the LED electronics and components of its properly installed LED products, to be free of defects in material and workmanship, in normal use, for a period of five (5) years from the date of shipment by Intense Lighting and warrants the painted finish for a period of one (1) year from the date of shipment by Intense Lighting. The painted finish of the product will be considered defective in material or workmanship only if there is substantial deterioration in the form of blistering, cracking, or peeling within the one (1) year warranty period. The painted finish is not warranted against fading or chalking, as it may naturally fade or chalk over time due to normal aging.

Intense Lighting, at its sole option, will repair, replace, credit or refund, any warranted product returned to it that it determines to be defective. Customer or consumer must return the product, transportation prepaid, to Intense Lighting at 725 Landwehr Road, Northbrook, IL 60062 within the warranty period. No return of products will be accepted without a Return Goods Authorization ("RGA"1 which may be obtained by calling 714-630-9877. This warranty excludes and there is disclaimed liability for labor for removal of this product or reinstallation of this product or a replacement product.

This warranty is void if the product is installed in violation of the National Electrical Code, or any applicable local electrical codes, or in an improper environment, misused, opened, abused, or altered in any manner, or is not used under normal operating conditions, or not in accordance with any labels or instructions. This warranty does not cover damages due to environmental conditions, acts of nature, animal or insect activity, or power surges.

THE ABOVE EXPRESS WARRANTY STATES THE FULL AND COMPLETE OBLIGATION OF INTENSE LIGHTING. ALL IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE ARE LIMITED IN DURATION TO THE TERM OF THE EXPRESS WARRANTY. UNDER NO CIRCUMSTANCES WILL INTENSE LIGHTING ACCEPT LIABILITY FOR ANY INCIDENTAL, CONSEQUENTIAL, SPECIAL, OR INDIRECT DAMAGES, INCLUDING, WITHOUT LIMITATION, DAMAGE TO OR LOSS OF USE OF ANY EQUIPMENT, LOST SALES OR PROFITS OR DELAY OR FAILURE TO PERFORM THIS WARRANTY OBLIGATION. THE REMEDIES PROVIDED HEREIN ARE THE EXCLUSIVE REMEDIES UNDER THIS WARRANTY, WHETHER ARISING OUT OF CONTRACT, TORT, STRICT LIABILITY, OR OTHERWISE. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

No distributor or supplier of Intense Lighting has the authority to modify or amend this Limited Warranty. This warranty may not be transferred or assigned by the original end user.
